Syllabus:

Aims and Learning Outcomes:

The purpose of this course is to familiarize students with the international and European systems of human rights protection. The course consists of four parts: I theoretical introduction, II the UN Human Rights System, III Europe's systems of human rights protection, IV International Judicial Bodies. Starting from a brief theoretical introduction about the nature and evolution of human rights, this course highlights on the evolution of the UN system of human rights protection (UDHR). Particular attention is paid to the treaty and charter based mechanisms of human rights protection (Human Rights Council, Human Rights Committee) and their practical functioning. The European System of Human Rights protection is covered holistically. Although the Council of Europe is in the center of the deliberations, the EU and the OSCE systems with their existing mechanisms map the complexity of the multicentric human rights reality
