



QUALIFICATION CRITERIA

Candidates have to be at least 18 years old and dispose a High School Diploma/Certificate or its equivalent bearing an Apostille or legalization from Polish Embassy; Prove the level of English proficiency is at least B2; get EASA First-Class Medical Certificate; pass Maths, Physics and English tests with the score of at least 75%.

REQUIRED DOCUMENTS:

- A passport-style photo uploaded into your personal account.
- Application Form - printed out from candidate's personal account in color and signed with your full name and surname.
- Passport scan - to confirm and verify your personal data.
- First-Class Medical Certificate approved by the European Union Aviation Safety Agency (EASA) and signed by its holder in indicated field.
- Original High School Diploma/Certificate with at least 55% of GPA legalized in the Polish Embassy or apostilled.
- **Sworn** translation of High School Diploma/Certificate and transcript of grades into Polish language.
- Eligibility statement or no-objection letter from the Ministry of Education, stating that the obtained High School Diploma/Certificate entitles candidate to continue the higher education in the country where the diploma/certificate was issued (if needed).
- Language certificate proving the level of language of your instruction is at least B2.
- Signed commitment to purchase National Health Fund (NFZ) insurance upon arrival.
- Payment confirmation of application fee and first semester tuition fee.
- Signed electronic agreement on the conditions of payment for studies and fees related to educational services.



HOW TO APPLY?

BACHELOR'S DEGREE IN AVIATION LAW AND PROFESSIONAL PILOT LICENCE

STEP 1

Register online to create your personal account on our [Admissions Platform](#). After activating your account please fill in all the required fields with your personal information. Please note that candidates should be at least 18 years old to be able to apply to this programme.

STEP 2

Get a First-Class Medical Certificate approved by the European Union Aviation Safety Agency (EASA). Initial Class 1 aero-medical examination can be performed only at the Aero-medical Centre (AeMC) certified to perform class 1 aero-medical examinations in one of the following countries: *Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Lichtenstein, Lithuania, Luxembourg, Malta, Netherlands, Norway, Poland, Portugal, Romania, Slovakia, Slovenia, Spain, Sweden, Switzerland*. Candidates who would like to take the medical examination in Poland should inform Admissions Office no later than 31.07.2025 and to be able to arrive in Warsaw before 16.09.2025.

STEP 3

Prove your English proficiency at B2 level at least and pass Mathematics and Physics provided to you by the Admissions Office on a separately agreed date and time with the score of at least 75%. To get an appointment for Mathematics and Physics tests - please contact the Admissions Coordinator at m.stefko@lazarski.edu.pl. The deadline is 31.08.2025.

STEP 4

Send scans of all the required documents as in the list below to our email address. After the documents are positively verified, the next step is to pay the application and tuition fees. Download your invoice from the main panel on your candidate's account. Please pay the full amount as stated on your invoice using your registration number as a payment reference (online payment is also available on your account).

STEP 5

After the documents are approved by our admissions team, collect the complete set and send it by post, courier or deliver it in person to our Admissions Office no later than **31.08.2025** in order to be admitted to studies.

After our team verifies the received original documents, you will get an acceptance letter to apply for student visa. Please check with your closest Polish Consulate how long it will take you to get a visa and apply early enough to be able to arrive in Warsaw before the end of September.

STEP 7

Welcome to Lazarski University!

Please remember that it is **very important** to arrive in Warsaw the latest **16.09.2025** to finalize the remaining formalities (such as: submitting an application to Aviation Authority, together with the notarial copy of your passport and entry visa).

NOSTRIFICATION

Please, consider that according to the Polish Educational Ministry Regulations some foreign students have to receive a Recognition of High School Diploma from the Polish Ministry of Education by the end of the first academic semester.

Our University helps students to complete the process (including sending a set of documents on your behalf). However, this is your obligation to deliver all the required documents to our office by the end of December 2024:

- ✓ Original HS diploma apostilled or legalized and transcript of grades for the senior years (last 3-4 years in High School depending on the country).
- ✓ Original Sworn translation of HS diploma and transcript of grades into Polish language including the translation of apostille or legalization stamps.
- ✓ Original Eligibility Statement from the Ministry of Education.
- ✓ Original Sworn translation of Eligibility statement into Polish.
- ✓ Copy of passport and valid visa.
- ✓ Form of Curriculum (with period of study and grading scale information) from the school.

Please, be kindly informed that failure to deliver the Recognition of your HSD may result in crossing you out from the list of students.

In order to check if Nostrification is needed please contact Admissions Office.

Dear Candidate,

If you are applying with the help of the educational agency – please, make sure that they have an official and legal right to represent our University. You can always ask your agency for a representation certificate or to confirm this information with the Admission Team.

Dear Agent,

If you want to enroll a candidate for studies but do not have a cooperation agreement signed with us – please, contact our Manager to discuss possible cooperation. Please, remember that you are not allowed to enroll and represent students without official cooperation with us.
